This includes but is not limited to dropped calls while using the phone in areas with weak signal strength. D) In the event of theft or loss, the client must immediately notify Roberts Rent a Phone and/or it agents and all relevant authorities. Failure to do so may result in unauthorized calls being charged to this rental. E) Before the rental begins, an authorization from the credit card(s) in the amount of \$1000.00 for each phone rented. At any time that the phone charges meet or exceed \$500.00, the credit card(s) will be charged for the call usage and another card authorization will be requested. F) The prices applicable are the ones applicable at the time of confirmation of the contract.
